

## ESTATE PLANNING INSTRUCTIONS

Please remember Point Foundation as you plan the details of your estate. Point Foundation is the nation's only scholarship fund for students who have faced barriers to higher education due to their sexual orientation, gender identity or gender expression. Make sure that your legacy lives on by investing in the future leaders of our community.

To honor, memorialize, and thank those friends of Point Foundation who have arranged a bequest or planned gift to the Foundation, we have established the Point Legacy Circle. Anyone who notifies Point Foundation that they have named the organization as a beneficiary of a bequest or planned gift will automatically be enrolled as a member.

Members of the Legacy Circle receive certain benefits. These currently include recognition in the Point Foundation annual report (if authorized by you), regular updates and invitations to select Foundation events. This will ensure your generosity endures for generations to come.

If you want to leave a donation to Point Foundation in the event that the party you originally intended the gift for predeceases you (contingent beneficiary):

"If any of the foregoing bequests shall lapse, then I bequeath to Point Foundation, a tax-exempt, not-for-profit, charitable institution whose headquarters are located in Los Angeles, CA with federal tax identification number 84-1582086 such bequests as to which an ineffective disposition was made."

If you want to leave parts of your estate to others and the remainder to Point Foundation (residuary legatee):

"All the rest, residue, and remainder of my estate, both real and personal, wherever located, I devise and bequeath to Point Foundation, a tax-exempt, not-for-profit, charitable institution whose headquarters are located in Los Angeles, CA with federal tax identification number 84-1582086."

If you want to leave assets to an individual (such as a partner or child) for use during their lifetime, but direct it to Point Foundation upon their death:

In this case, a more sophisticated vehicle, such as a charitable trust or pour-over trust, may be most effective. Please discuss this with your estate planner.

Sample language prepared for:

These endowed scholarships will be used to cover direct financial scholarship expenses, as well as programmatic expenses related to the selection process as well as mentoring and leadership programs delivered by Point Foundation to scholar(s).		
My preferences for the awarding of this scholarship are as follows:		
<ol> <li>The scholarship shall be namedScholarship.</li> <li>Awards can go to any eligible LGBTQ student attending a 4-year college or university, graduate school program, or community college.</li> <li>There is no geographic or demographic preference.</li> <li>There are no restrictions on area of study.</li> </ol>		
Point will market, solicit, select and execute the Flagship Scholarships and Community College Scholarships. Point Foundation will identify a scholar through their standard selections process.
